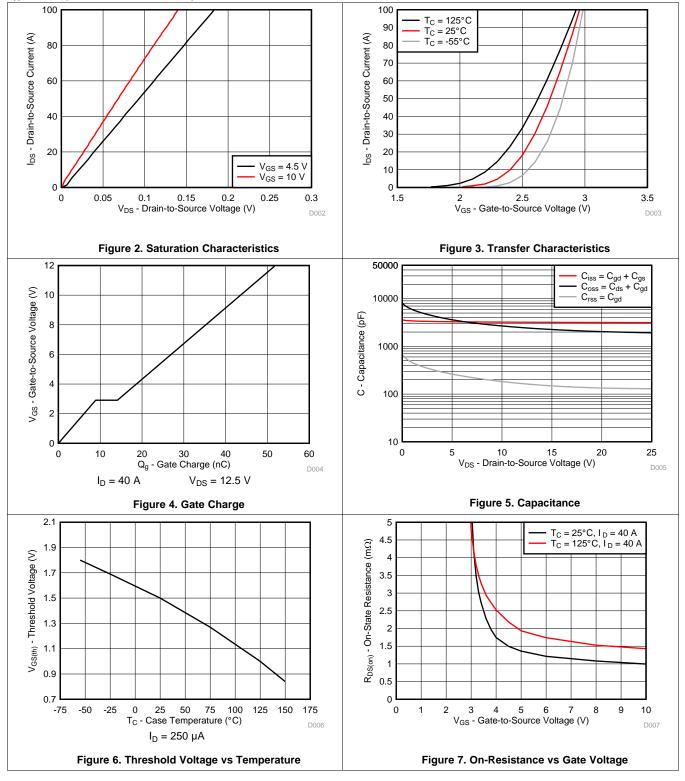

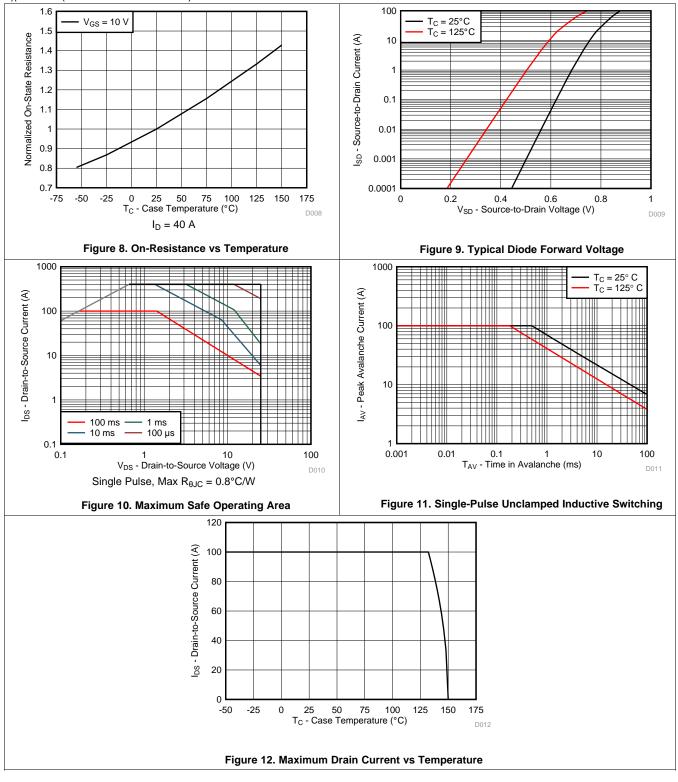

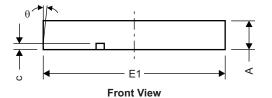
Top View

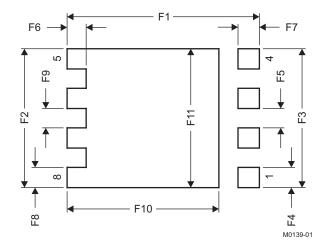

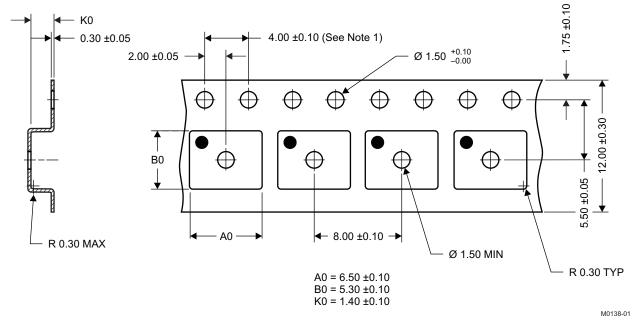

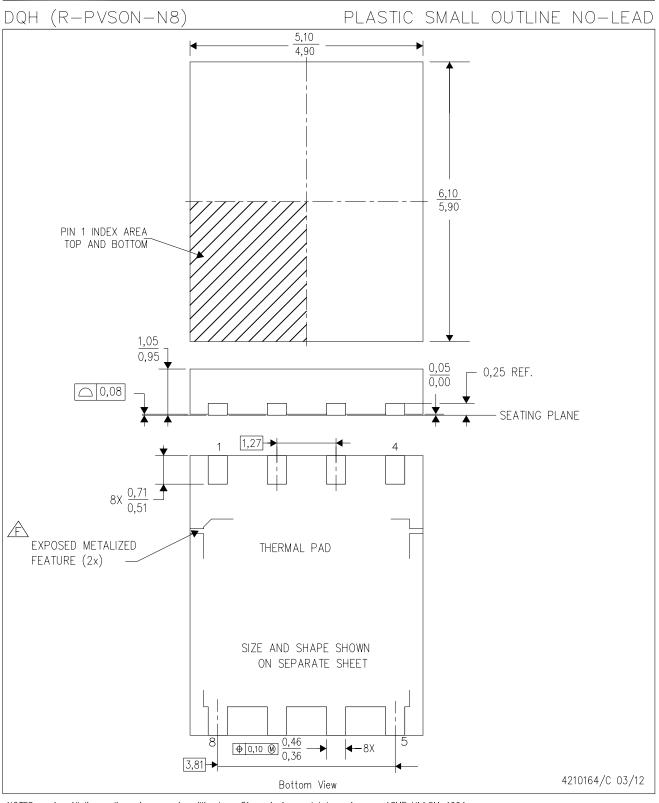
